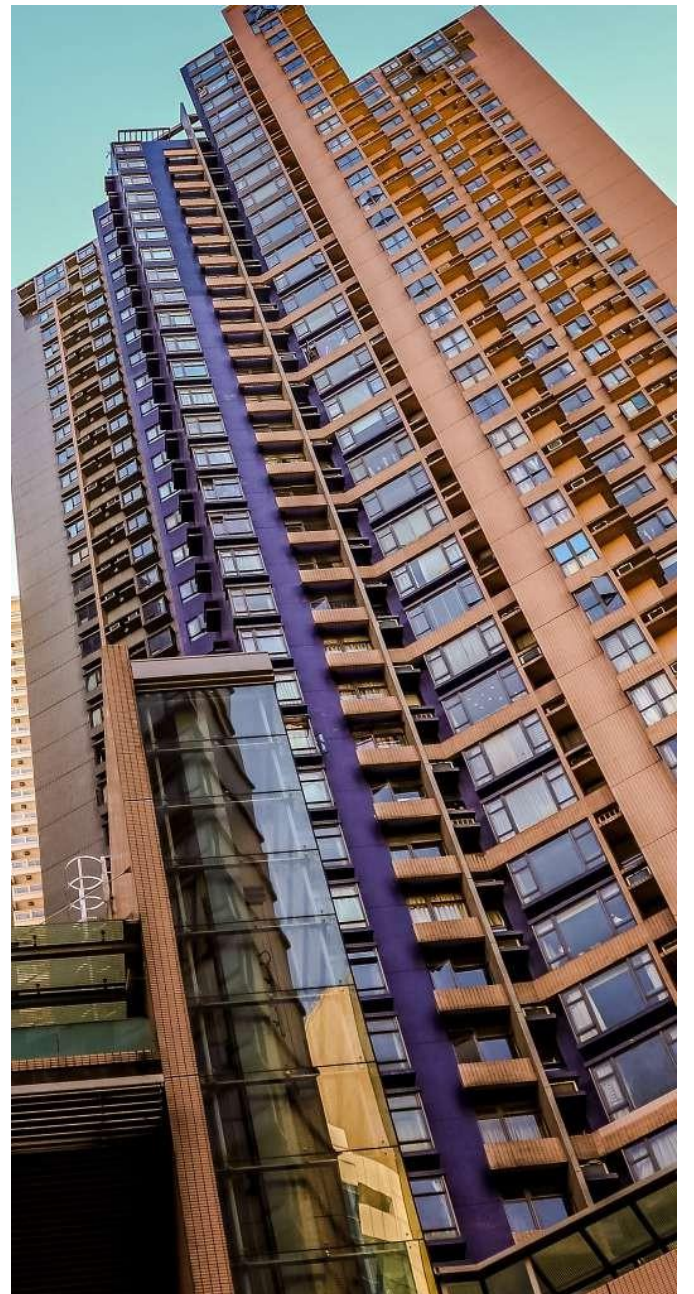
Agribusiness yields high returns, Agriculture when done the right way has the ability to yield a plentiful harvest even with just little investing done.

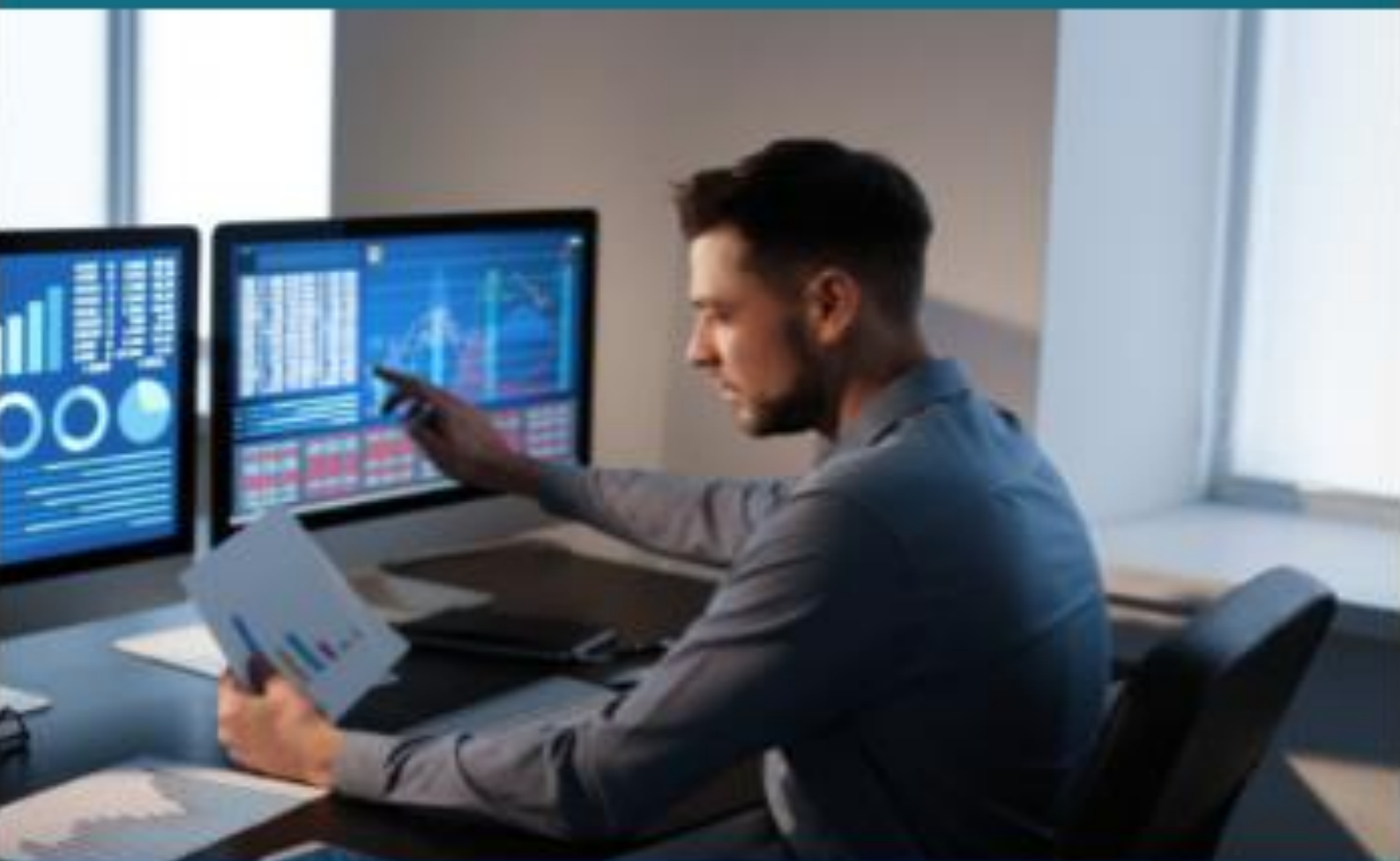

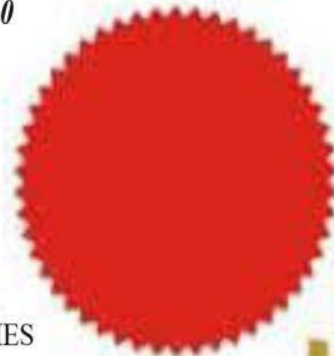
